

FOOD WASTE COLLECTION

RECOLECCIÓN DE DESECHOS DE COMIDA

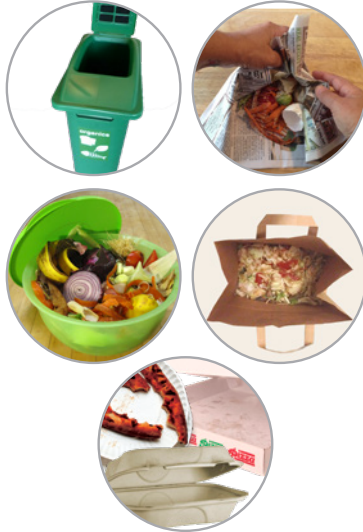
SEPARATE SEPARARE

- Separate Food Waste while preparing meals or scraping plates.



COLLECT RECOLECTE

- Use a reusable plastic tub or any compostable paper container such as non-coated take-out boxes or paper bags.
 - Use shredded paper to line your containers or wrap in newspaper to help prevent leaks and odors.
 - Include food-soiled paper such as coffee filters, non-coated paper plates, napkins, paper towels, paper or parchment, and non-coated take-out containers.
- DO NOT INCLUDE PLASTICS**
LABELED "COMPOSTABLE".



DISPOSE DESECHE

- Empty into green organics cart or bin.



Grant funds may be available (up to \$500 per business) to buy indoor containers for separate storage of organics. The link to the application is here: www.recyclingrulesac.org/containers/.

RECYCLING MANDATES

ORDENANZAS DE RECICLAJE

Recycling and composting conserves natural resources, saves landfill space, and reduces greenhouse gas emissions. By recycling right, you can reduce your level of trash service and therefore reduce your bill.

PROPERTY OWNERS MUST:

- Ensure that tenants have the required services
- Subscribe to the required collection services
- Provide indoor containers for temporary storage, as well as signage on or near those containers
- Annually provide collection requirements to tenants, employees and contractors

Recyclable and organic materials must be placed in the designated outdoor containers. Please do not place these materials in the green metal trash bin or burgundy cart.

Printed materials available at no charge include labels for your containers and posters for reference by employees or patrons.

CART & BIN SET-OUT REGULATIONS

REGLAMENTOS DE COLOCACIÓN DE BOTES Y RECIPIENTES

Carts or bins may not be placed curbside earlier than 6:00 a.m. the day before the regular collection day. Carts must be retrieved and placed on private property and out of view from the street no later than midnight on your scheduled collection day (HMC 5-1.15).

Clean Paper, Magazines, Newspaper, Cardboard, Junk Mail, Paper Beverage Cartons (must be empty)



All Metal Beverage & Food Cans, Empty Aerosol Cans, Clean Aluminum Pans & Foil



Glass Bottles & Jars (Even broken)

Empty Plastic Bottles & Containers (Lids should be left on after emptying contents)



Recyclables should be empty, clean, and dry. Do not bag recyclables.

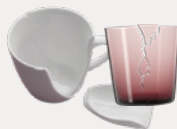
Wax-lined Food Cardboard Boxes



Disposable Gloves & Hairnets



Hoses, Cords & Wire



Broken Glass & Dishes (Please Wrap)



Plastic Lined Paper Cups & Lids, Plastic Utensils & Straws, To Go Containers (Including "compostable" plastic)



Avoid an Overage Charge

Materials must fit inside a container with the lid shut when serviced or you may be charged. If you regularly have excess materials, call WM at (510) 537-5500 to help you right-size your service.

Food Scraps, Including Egg Shells, Meat & Bones



Food-Soiled Paper, Napkins, Paper Towels, Pizza Boxes, Cardboard Egg Cartons, Non-coated (plastic lined) Take-out Containers & Paper Plates (No surface sheen)



Coffee Grounds & Tea Bags



Yard Waste, Untreated Wood



No Loose Plastic Bags

No loose plastic bags are allowed. Commercial customers may use either clear bags (where the contents are visible) or BPI compostable bags to contain organic material.
